FUND OBJECTIVE

The Fund's primary investment objective is to seek current income. The Fund's secondary investment objective is to seek exposure to the performance of one or more exchange-traded funds whose shares trade on a U.S.-regulated securities exchange and that seek daily leverage investment results of 3 times (300%) the daily percentage of the common stock of Nasdaq-100 Index. (NASDAQ: QQQ) (the "Underlying Asset") subject to a limit on potential investment gains.
